#### ORDER

As per the letters read as 2<sup>nd</sup> paper above, the Registrar of Co- operative Societies has forwarded a proposal for approval of the Guidelines for the payment of financial assistance by way of Grant to SC/ST Co-operative Societies for maintenance of Building, Conducting training and Workshops for Board members and Employees of SC/ST Societies based on the decision of the Working Group Meeting held on 16.11.2013.

Having examined the matter in detail, Government are pleased to approve the Guidelines for the payment of financial assistance by way of Grant to SC/ST Co-operative Societies for maintenance of Building, Conducting training and Workshops for Board members and Employees of SC/ST Societies, subject to the existing financial delegation of powers of Government. # <u>SC/ST Co-operative Societies for maintenance of office Building.</u> <u>Conducting training and workshops for Board members and Employees of SC/ST Societies</u>

1. These guidelines may be called the guidelines for the payment of financial assistance by way of Grant to SC/ST Co-operative Societies for the expenditure to be incurred for the repair & maintenance of Office Building, Conducting training programmes and workshops for Board members and employees.

#### A. Maintenance of Office building.

- 2. The maximum assistance payable to a society under these guidelines shall be Rs. 5 lakhs
- 3. Assistance for repair and maintenance of office building is sanctioned based on the approved estimate by a competent authority submitted by the societies which have minimum 3 years satisfactory working. If the repair includes alteration or extension or addition, along with the estimate a plan approved by the Govt. Engineer, not below the rank of Assistance Engineer should also be submitted.
- 4. Repair and maintenance grant shall be given to the buildings constructed on or before 31.3.2005, and owned by the society.
- 5. The Registrar of Co-operative Societies shall be competent to sanction the grant of subsidy to the SC/ST Societies subject to availability of funds
- Grant for conducting workshops/Training Programmes for the Managing
   Committee members /Employees
   Grant for conducting Workshops and Training Programmes under these
   guidelines shall be given to the Institutions approved by the Registrar of Co-

operative Societies by way of reimbursement of the cost incurred for conducting the training programms for SC/ST Co-operatives under the control of Registrar of Co-operative Societies.

2. The Study/training includes field visits also.

#### **GENERAL**

- 1. The assistance given under these guidelines shall be utilized only for the purpose for which it is sanctioned.
- 2. The application for assistance shall be forwarded to Registrar of Cooperative Societies through the Joint Registrar concerned with his recommendation in the form appended to these Guidelines.
- 3. The Application should be accompanied with the following resolutions and certificates.
  - I) Resolution that the society shall adhere to such terms and conditions as Government/Registrar of Co-operative Societies may prescribe from time to time.
- ii) An evaluation report on the working of Co-operative Society by the Assistant Registrar of Co-operative Societies (SC/ST) attached to the office of the Joint Registrar(General)
- iii) Certificate by the Joint Registrar to the effect that the Society is free from corrupt practices.
- 4. Audit of the society shall be completed up to the preceeding year.
- 5. The amount sanctioned shall be drawn by the Joint Registrar of Co-operatives (General) of the District concerned

6. Financial assistance shall be released to the society after an agreement is signed between the society and Government. The said agreement shall prescribe terms and conditions under which the financial assistance is being sanctioned. Failure to fulfill the conditions by the society shall make the society liable to repay the entire amount sanctioned with penal Interest within the period to be specified in the agreement.

- 7. Notwithstanding anything contain in these guidelines or in the bye-laws of the society it shall be open to the Registrar of Co-operative Societies to withdraw at any time without stating any reason the whole or any portion of the assistance and that society shall be liable to refund the amount so withdrawn.
- 8. The president, Secretary, all members of the managing committee of the society shall, by jointly and severally be responsible for the proper utilization of the assistance under these guidelines.

- 9. The Joint Registrar (General) will watch the prompt utilization of the assistance. The Joint Registrar shall obtain utilization certificate for the amount sanctioned from the society and forwarded to Registrar of Co-operative societies for onward transmission to Accountant General.
- 10. The Registrar of Co-operative Societies will have power to relax all or any of the Provisions contained in these guidelines in deserving cases.

- 2. The Society agree to and shall abide by the terms and conditions contained in guidelines governing the assistance, a copy of which is herewith appended and the Guidelines shall form part of the agreement.
- 3. The Society agree to utilize the grant within one year from the date of sanction of amount and any amount remaining unutilized shall be refunded to Government.
- 4. Notwithstanding anything contained in Guidelines or in the bye-law of the society, it shall be open to the Government to withdraw at any time without

stating any reason the whole or any portion of the financial assistance and that the society shall be liable to refund the amount so withdrawn. In case the society commits breach of all or any of the terms and conditions herein contained or those contained in the Guidelines, the entire amount sanctioned shall become repayable in lump at once by the society.
