NOTIFICATION

G. O. (P) No. 34/2014/Co-op. Dated, Thiruvananthapuram, 15th February, 2014.

S. R. O. No. 121/2014.—WHEREAS, as per notification issued under G.O (P) No. 22/2011/Co-op dated 8th February, 2011 and published as S. R. O. No. 110/2011 in the Kerala Gazette Extra Ordinary No. 286 dated 8th February, 2011, the Government have appointed Shri C. S. Satheesh, C. S. Cottage, Moothala, P. O., Pallickal, Kilimanoor, Thiruvananthapuram as the Presiding Officer of the Co-operative Arbitration Court, (Southern) subject to the condition that the Presiding Officer shall hold Office till he attains the age of superannuation as applicable to State Government Employees;

AND WHEREAS, as per notification issued under G.O (P) No.19/2012/Co-op dated 14th February, 2012, and published as S.R.O. No. 137/2012 in the Kerala Gazette Extra Ordinary No. 411 dated 1st March, 2012, the Government have amended rule 67 of the Kerala Co-operative Societies Rules, 1969, to the effect that the Presiding Officer of the Co-operative Arbitration Court shall be an advocate having not less than seven years bar experience and who shall be appointed by Government for a period of three years;

AND WHEREAS, the term of office of Shri C. S. Satheesh will expire on 16th February, 2014 as he completes three years of service as Presiding Officer;

NOW, THEREFORE, in exercise of the powers conferred under section 70 A of the Kerala Co-operative Societies Act, 1969, (Act 21 of 1969) read with rule 67 of Kerala Co-operative Societies Rules, 1969 the Government of Kerala hereby appoint Sri Rajan Velloth, Dreams, Pachapoika, P.O., via Kuthuparambu, Kannur - 670 643 as the Presiding Officer, Co-operative Arbitration Court, (Southern) for a period of three years with immediate effect.

Explanatory Note

The term of office of Shri C. S. Satheesh appointed as the Presiding Officer of the Co-operative Arbitration Court vide notification issued under G.O (P) No. 22/2011/Co-op dated 8th February, 2011 will expire on 16th February, 2014, and Government have decided to appoint Sri Rajan Velloth, Dreams, Pachapoika, P.O., via Kuthuparambu, Kannur-670 643 as the Presiding Officer of the Co-operative Arbitration Court (Southern) for a period of three years with immediate effect.
