ORDER

(1) In the Government order read as first paper above orders were issued prescribing the terms and conditions for awarding Government works to Labour Contract Co-operative Societies.

(2) As per the GO read as 2nd paper above the limit for each item of work that can be entrusted to the Labour Contract Co-operative Societies and the total value of works a society may have on hand at a time are regulated as follows:

Class of Society	Limit for each item of work	Maximum value of works on hand at a time	Audit classification	Average number of members employed by the society at least 200 days in one year for the last three years or last year.
A class	Rs.20.00 lakhs	Rs.100.00 lakhs	A or B	150
B class	Rs.10.00 lakhs	Rs. 50.00 lakhs	A or B	100
C class	Rs.4.00 lakhs	Rs.20 lakhs	B or C	25

(3) It is observed that many of the Labour contract Co-operative Societies are often confronted with difficulties to participate in the tendering of works adhering to this limits fixed. The increase in the cost of construction makes the cost of a work more than the limit prescribed in the Government Order

read as 2nd paper above that prevents most of the Labour Contract Co-operative Societies to participate in the tender for works invited by the Local Self Government institutions under the policy of planning through Public participation. Several Labour Contract Co-operative Societies have approached Government for special sanction from Government for enhancing the limits. As per the letter read as 3rd paper above, Registrar of Co-operative Societies has recommended Government to revise the present limits by amending para 5 of the Government Order read as 2nd paper above.

(4) Government have examined the matter in detail and are pleased to enhance the limits that entrusted to the Labour Contract Societies prescribed in para 5 of the Government Order read as 2nd paper above as follows:

Class of Society	Limit for each item of work. (Rs.in lakhs)	Maximum value of works at a time (Rs. in lakhs)	Audit classification
A	40	200	A or B
B	20	100	A or B
C	8	40	B or C


