ORDER

In the G.O read as first paper above, guidelines for procurement operations of Copra during 2005 season was issued by the Government and subsequently modified as per the GOs read as second, third and fourth papers above and the same would strictly be adhered to for the procurement of copra during 2012 season also. As per GO read as fifth paper above KERAFED and MARKETFED have been designated as the State Level Agencies of NAFED for procurement operations of Copra for 2012 season with the condition that the guidelines for procurement of copra under the MSP scheme issued by the Government as per G.O read as first paper above and subsequently modified as per the GOs read as second, third and fourth papers above will remain unchanged and the same should be strictly adhered

to for the procurement of copra during 2012 season. The Coconut Development Board vide letter read as sixth paper above has requested Government to exempt Coconut Producers Societies(CPS) registered under the Coconut Development Board from producing certificate of the Agricultural Officer and to accept the registration certificate issued by the Coconut Development Board to the Coconut Producers Societies(CPS) registered under CDB as a proof of document to take the stock under the Price Support Scheme.

Government having examined the matter in detail, are pleased to direct KERAFED and MARKETFED to accept the registration certificate of Coconut Producers Societies issued by the Coconut Development Board also while procuring FAQ grade milling copra under PSS. The Coconut Development Board shall ensure the genuiness of farmers.

The Government Order read as first paper above stands modified to the above extent.
