Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 57B of the Kerala Co-operative Societies Act, 1969 empowers the Government to frame a scheme to be called the Deposit Guarantee Scheme specifying the purpose of the scheme and shall be administered in such manner as may be specified therein. Accordingly, as per G. O. (P) No. 3/2012/Co-op. dated 11th January, 2012 Government made the Kerala Co-operative Deposit Guarantee Scheme, 2012. Paragraph 6 of the said Scheme provides for the constitution of the Kerala Co-operative Deposit Guarantee Fund Board for the administration of the fund. The Government have decided to constitute the said Board with the members in the notification.

The notification is intended to achieve the above object.
