ORDER

Proposals for financial assistance in respect of Co-operative Societies under NCDC and State Plan Scheme are usually placed in the Working Group for sanction. Even after placing the proposal in the Working Group, the proposals are again sent to Finance Department and Planning and Economic Affairs Department to get their clearance to withdraw the Fund. This consumes much time and energy and causes inordinate delay in incurring expenditure every year.

Accordingly, the Working Group held on 27.05.2014 has resolved to examine the possibility of enhancing the financial powers of the Registrar of Co-operative Societies both in the State Plan and NCDC Scheme for the release of Fund. At present, the Registrar of Co-operative Societies has the financial power to sanction upto ₹ 3.00 Lakh to the beneficiary societies under NCDC sponsored scheme vide Government Order read as 2nd paper above.

The rule is not amended since 1998 and the same is outdated. Accordingly, the Working Group held on 31.07.2014 has directed the Registrar of Co-operative Societies to submit proposal for enhancing the monetary ceiling to be sanctioned by the Registrar of Co-operative Societies, up to ₹ 20.00 Lakh.

As per the letter read as 4th paper above, the Registrar of Co-operative Societies has submitted proposal for enhancing the financial powers of Registrar of Co-operative Societies both in State Plan and in NCDC Scheme upto ₹ 20.00 lakh and ₹ 10.00 lakh respectively.

Government have examined the matter in detail. The existing rules and regulations are to be amended from time to time for better efficiency in Government business. Considering these facts, Government are pleased to enhance the financial powers of Registrar of Co-operative Societies for the release of Fund both in State Plan and in NCDC Scheme up to ₹ 20.00 Lakh and ₹ 10.00 lakh respectively subject to the following conditions.

1. The scheme for approval should be included in the Budget for the financial year.
2. All new schemes / components are to be placed before the Working Group for approval.
3. Amount will be sanctioned based on detailed project report.
4. Before scheme approval, it should be ensured that it satisfies all the conditions instructed for Working Group approval. The conditions stipulated in the eligibility criteria for selection of societies , rules for payment of a particular assistance , the check list covering audited year, net worth status , etc are to be scrutinized . In every year, the Norms should be finalised in the 1st Meeting of the Working Group of the financial year. Based on the approved Norms for the year regarding audited year , net worth, and other criteria, Registrar of Co-operative Societies can issue sanction for the amount delegated . Separate priority and norms for approval of NCDC loan also should be finalized in the 1st Meeting of the Working Group , every year.
5. Societies requesting assistance more than once will be considered only after evaluating their working progress and performance.

The above Rules will come into existence with effect from 01.04.2016 onwards.


